## **Professional Experience**

Nick was admitted to practice as a barrister and solicitor in 1998. He signed the Victorian Bar roll in 1993, and took silk in November 2013.

Nick has acted in a wide range of commercial (predominantly building and construction) disputes. He has particular experience in oil, gas, desalination plants, road and rail infrastructure, the construction of pipelines, and in prosecuting and defending delay and disruption claims.

He has extensive experience working on heavy and complex cases as part of a team made up of solicitors and other counsel. He has extensive experience in arbitration (domestic and international), including stop clock arbitration.

In the last three years Nick has acted for:

- The contractor in the Sydney Light Rail dispute. The dispute involved variation claims, extensions of time claims and delay and disruption claims.
- The contractor in an arbitration against the principal in relation to the Ichthys LNG onshore plant. The dispute predominantly involves delay claims and variation claims.
- The principal in a dispute relating to the design and construction of waste water treatment facilities at the ERA Ranger Uranium Mine.
- The principal in a dispute relating to the failure of the HVDC cable known as the Basslink cable.
- The Builder in a claim against subcontractors and consultants in relation to recovery of the cost of replacing combustible cladding on a major Melbourne hospital.
